


IFAC SAFA Workshop



For this purpose, the 'Join interactive Question and Answer session on the Implementation of IFRS Sustainability Disclosure Standards (IFRS S1 and S2) in Pakistan' was organized on September 07, 2023 for the industry participants. The session aimed to hold an interactive consultation and discussion with companies representatives on the adoption and implementation of IFRS S1 and S2 in Pakistan. The session covered an overview of these standards and also showcased the proposed applicability criteria of these standards and the introduction of draft sustainability report.

INTERACTIVE CONSULTATIVE SESSION WITH AUDIT FIRMS ON IFRS SUSTAINABILITY DISCLOSURE STANDARDS

ICAP hosted a similar interactive consultative session with audit firms on September 14, 2023 at ICAP Karachi. The session aimed to provide audit firms an overview of IFRS S1 & IFRS 2 and

their applicability criteria along with the introduction of the draft illustrative Sustainability Report format to the participants. The event was attended by esteemed participants from various audit firms.

The IFRS 17 working group of Accounting Standards Board on **August 08, 2023**, conducted an awareness session through webinar in which Mr. Omer Mustafa Ansari and Mr. Haroon Tabraze delivered presentation on FAS 42 "Presentation and Disclosures in the Financial Statements of Takaful Institutions"; and FAS 43 "Accounting for Takaful: Recognition and Measurement", developed by AAOIFI, for awareness of SECP and participants from takaful industry. The session includes discussion and suggestion for adoption of these standards in conjunction with IFRS 17.
